Evaluate which English translations of the Bible best represent Anglican exegesis.  J.2	Become involved in ecumenical Bible translation programmes to ensure that Anglican exegesis is considered in Bible translation  Give Anglican exegesis feedback during translation process.  Ensure that Bible translations are coordinated with translations of the Anglican Liturgy.
